## GCSE Results Summer 2018

Enclosed are your results for the exams completed in summer 2018. Keep your results slips safe as they are proof of your accreditation until you receive your certificates. These will be available from the Main School Reception from mid-November 2018.

If there are any problems or issues arising from your results you must inform the Exams Officer (Mrs Sellar) as soon as possible. If you believe you may need a re-mark or scripts returned you need to seek advice from your subject teacher. If you wish to request Access to Script (ATS) you must complete and sign the Enquiry, Consent and Payment Form (available from Mrs Sellar, or the Rednock School website)

Should you wish to re-sit GCSE Maths or English in November 2018 please see Mrs Sellar at the start of term in September to obtain a re-sit form. Your re-sit form will need to be signed by your subject teacher and returned to Mrs Sellar by Friday 21<sup>st</sup> September 2018 along with payment.

1	EAR Service 1: Clerical re-check	<i>This is a re-check of all clerical procedures leading to the issue of a result. This service will include the following checks:</i>
2	EAR Service 1 with a copy of re-checked script requested	<ul style="list-style-type: none"> <li>• <i>that all parts of the script have been marked;</i></li> <li>• <i>the totalling of marks;</i></li> <li>• <i>the recording of marks.</i></li> </ul>
3	EAR Service 2: Mark review	<i>This is a post-results review of the original marking to ensure that the agreed mark scheme has been applied correctly. This service will include:</i>
4	EAR Service 2 with a copy of reviewed script requested	<ul style="list-style-type: none"> <li>• <i>the clerical re-checks detailed in Service 1;</i></li> <li>• <i>a review of marking as described above.</i></li> </ul>
5	EAR Priority Service 2: Mark review	<i>This service is as Service 2. However, it is only available if a GCE A-level candidate's place in higher education is dependent on the outcome.</i>
6	EAR Service 3: Moderation review	<i>This is a review of the original moderation to ensure that the assessment criteria have been fairly, reliably and consistently applied.</i>
7	ATS: Priority copy of script	<i>This service is available for GCE AS and A-level scripts to help decide if an EAR service 1 or 2 should be applied for; this service is not available if an EAR priority service 2 is applied for.</i>
8	ATS: Original script	<i>Awarding bodies will provide either the original hard copy script or an electronic image of the script.</i>
