




School Admission Policy

The Blessed Peter Snow Catholic Academy Trust



The Catholic Voluntary Academies which form the Blessed Peter Snow Catholic Academy Trust are distinctive as we provide grounding in the Catholic Faith for all our children. The special character of our Catholic academies is the quality of the religious teaching, integrated into the overall education of our children. Our beliefs, which are Gospel centred, affect the way we live, making our academies living examples of Christ and His teachings.

"Education is not and must never be considered as purely utilitarian. It is about forming the human person, equipping him or her to live life to the full – in short it is about imparting wisdom. And true wisdom is inseparable from knowledge of the Creator." (Pope Benedict XVI, Address to Teachers and Religious, Twickenham, September 2010).

Our Academies therefore operate and are informed by the following four key principles of Christian formation:

- **Places of Discipleship**
- **Places where Communities are created**
- **Places of Learning**
- **Places where we treasure God's World**

In light of the above principles, the Trust aims to:

- ensure secure, welcoming and engaging environments in which all individuals learn to value and respect both themselves and others
- provide all individuals with the opportunities to achieve excellence, to develop their full potential as human beings and to encourage and challenge them to do so
- uphold the unshakable belief in the unique potential of each child, student and member of staff
- provide a curriculum that initiates students into the knowledge, values, attitudes and skills they need to become mature Christian adults in their personal, social, family and working lives.

Saint John Fisher Catholic Voluntary Academy was founded by the Catholic Church to provide education for children of Catholic families. The school is run by its Governing Body as part of the Catholic Church in accordance with its Trust Deed and Articles of Association, and seeks at all times to be a witness to Jesus Christ.

If the number of preferences received is less than the admission number then all preferences will be met. However, when there are more applications than places available, priority will always be given to Catholic applicants in accordance with the oversubscription criteria listed below. By applying to this school parents, or carers, are declaring their support for the aims and ethos of the school.

The Blessed Peter Snow Multi Academy Trust is the admissions authority which has responsibility for admissions to the school and intends to admit 198 pupils to Year 7 in the school year which begins in September 2019. The local Academy Council has delegated responsibility for managing admissions.

Over Subscription Criteria

At any time where there are more applications for places than the number of places available, places will be offered according to the following order of priority.

1. Looked after children from Catholic families or children from Catholic families who were previously looked after but ceased to be so because they became adopted or became subject to a residence or special guardianship order with a sibling who attends St John Fisher Catholic Voluntary Academy.
2. Looked after children from Catholic families or children from Catholic

families who were previously looked after but ceased to be so because they became adopted or became subject to a residence or special guardianship order.

3. Baptised Catholic children with a sibling who attends St John Fisher Catholic Voluntary Academy.
4. Baptised Catholic Children who live in the Primary School defined areas of Holy Spirit Heckmondwike, St Francis Morley, St Joseph's Batley Carr, St Mary's Batley, St Patrick's Birstall, and St Paulinus Dewsbury and who attend the Catholic Primary Schools serving those areas.
5. Other Baptised Catholic children resident in the above defined areas.
6. Baptised Catholic children who currently attend one of the Catholic Primary Schools named in (4) but do not live in the defined area.
7. Other Baptised Catholic Children.
8. Other looked after children or other children who were previously looked after but ceased to be so because they became adopted or became subject to a residence or special guardianship order with a sibling who attends St John Fisher catholic Voluntary Academy.
9. Other looked after children or other children who were previously looked after but ceased to be so because they became adopted or became subject to a residence or special guardianship order.
10. Other children with a sibling who attends St John Fisher Catholic Voluntary Academy.

11. Other children who currently attend one of the Catholic primary schools listed above.

12. Other children.

Tie Break

- Where the offer of places to all the applicants in any of the categories listed above would lead to over-subscription, the places up to the admission number will be offered to those living nearest to the school. Distance is measured in a straight line from a child's home address to the school. Measurements are calculated using six-figure grid references for each address taken from Ordnance survey ADDRESS-POINT® data. This grid reference relates to a point that falls inside the permanent building structure corresponding to the address. The boundary of the building structure for the address is derived from Ordnance Survey Land-Line data. For smaller, residential properties the grid reference denotes a point near the centre of the building. For larger properties like schools with, for example, multiple buildings and large grounds, the grid reference relates to a point inside the main addressable building structure. The distance calculated is accurate to within 1.0 metres.
- If two or more pupils live equidistant from the school, the distance each pupil lives by road from the school will be measured and the place offered to the pupil who lives nearest by this means. In the event of this being equal, places will then be decided by random allocation (see notes).
- Where there is more than one application from a postal address contained within a block of flats,

places will be decided by random allocation (see notes).

Admission to Sixth Form

The sixth form is available for all existing pupils. 30 remaining places in the sixth-form of the school will be distributed in line with the oversubscription criteria. All applicants must meet the requirements of individual courses.

Application Procedures and Timetable

A standard application form from the parents' home Local Authority (LA), known as the Common Preference Form, must be completed and returned to the home authority by 31st October 2017. Failure to provide a Common Preference Form (CPF) would mean that the application is not valid.

If parents feel that they should be in a specific category i.e. Baptised Catholic, then they are required to complete a Supplementary Information Form and provide the required evidence. The Supplementary Information Form is attached to this policy and should be submitted by 31st October 2017 to the the Admissions Officer, St John Fisher Catholic Voluntary Academy, Oxford Road, Dewsbury, WF13 4LL For those pupils attending the primary schools identified in 4 above, this may be done through these schools. Therefore, failure to provide a Supplementary Information Form (SIF) could affect the category your application is placed in. Please note that it is the responsibility of the parent/carer to complete all forms and supply evidence – reminders will not be sent.

Parents will be advised of the outcome of their application on 1st March 2018. Unsuccessful applicants will be given reasons related to the over-subscription criteria listed above and advised of their right of appeal to an independent appeal panel.

Late applications

If you return the Common Preference Form after the deadline, we cannot consider your application at the same time as those received on time. Late applications will be dealt with once all other applicants have been considered.

Admissions outside the normal admission

Applications should be made to the school and will be dealt with by the admission authority of the school i.e. the Academy Council. If there is more than one application for an available place the governors will make their decision using the oversubscription criteria listed in the appropriate policy for the year group. Unsuccessful applicants will be given reasons related to the oversubscription criteria listed above and will be advised of their rights to appeal the governors' decision to an independent appeal panel.

Waiting Lists

As well as their right of appeal, unsuccessful applicants will be placed on a waiting list. This waiting list will follow the order of the oversubscription criteria set out above, therefore, this means that each time a child is added the list will be re-ranked. Names are normally taken off the list at the end of the academic year.

Pupils with a Statement of Special Educational Needs or Education, Health and Care Plans.

The admission of pupils with a Statement of Special Educational Needs or Education, Health and Care Plan is dealt with by a completely separate procedure. This procedure is set out in the 1996 Education Act. Details of this separate procedure are set out in the *Special Educational Needs Code of Practice*.

If a child has a Statement of Special Education Need or Education, Health and Care Plan naming a school then the child is automatically offered a place at the named school.

Notes (these notes form part of the over-subscription criteria)

Catholic means a member of a Church in communion with the 'See of Rome'. This includes the Eastern Catholic Churches. A certificate of baptism in a Catholic Church or a certificate of reception into the full communion of the Catholic Church will normally evidence this. Alternatively a letter from a parish priest confirming membership of a church in communion with the See of Rome. This includes the Eastern Catholic Churches. Looked After Child has the same meaning as in section 22 of the Children Act 1989, and means any child in the care of a local authority or provided with accommodation by them (e.g., children with foster parents).

Looked After Children from Catholic Families – this has a dual meaning. It could be the child themselves who are baptised Catholic or it could be the family who are caring for the child that is Catholic. If it is the child who is a baptised Catholic normal rules apply and a baptism certificate should be seen by the admission authority. However, (in limited situations) this may not always be possible and in these cases the admission authority will seek to ensure that the child is baptised. If a child is placed with a Catholic family who

wish the child to have a Catholic education this should be evidenced by a baptism certificate of either parent carer.

Distance will be measured as in the Tie-Break above.

Siblings (Brother or Sister) includes children with brothers or sister (including step-siblings, adoptive siblings and foster siblings) of statutory school age, living at the same address, in attendance at the same school on the date of admission.

Twins or Triplets - where a family of twins or triplets request admission and if one sibling has been offered the last place the 'excepted pupil' rule comes in and the other twin/triplets are offered a place.

Live - In all categories "live" means the child's permanent home address. A child is normally regarded as living with a parent or guardian and we will use the parent or guardian's address for admission purposes. You cannot lodge a child with a friend or relation in order to gain a place at a school. For admissions purposes only one address can be used as a child's permanent address. When a child lives with more than one parent/carers, at different addresses, we will use the preference expressed by the parent/carers at the address where the child lives the majority of the time during the school week as the main place of residence.

Defined area – the defined area is shown on a map available for inspection at the school.

Random Allocation – this is only to be used when the last place to be offered would fall into one of the two categories highlighted above i.e. children living in a block of flats or children who live equidistant from the school using straight line distance criterion. An independent person will be used to make the random selection.
